The above inter-district transfers are subject to the following stipulations:

1. The GPTAs, under orders of transfer, are required to join in their new places of posting (District) availing the minimum transit by the shortest route, after their relief from their present place of posting (District).

2. On joining in the new District, the GPTAs are required to execute the agreement (format copy of which has already been supplied to the Districts earlier) with the Collector-cum-CEO, Zilla Parishad.

3. The Collectors to ensure detailed Block posting in the Districts, soon after their joining.

4. The GPTAs should not be posted to their native Blocks.
