# Guidelines/Terms & Conditions for Empanelment of Audio Visual Producers

**I&PR Dept.**, Govt. of Odisha wished to empanel audio-visual producers with intention to utilize their services for production of audio visual publicity of various government policies and programmes. Various Departments under the Government of Odisha require the services of audio-visual agencies/producers for publicity of their programmes and policies. The empanelled audio-visual producers will work as an agency with **I&PR Department** and will be used as a pool for carrying out such activities.

#### GENERAL:

- 1. These guidelines shall supersede all guidelines/ rules/norms/precedents, in existence in this regard.
- 2. These Guidelines shall come into force with immediate effect.
- 3. **I&PR Department** proposes to classify producers in the following Sectors on the experience shown by the producers in those Sectors. The applicant will specify the sectors in which he has past experience and his interest in doing future work as well, in the order of preference, in the application form. I&PR Department will try to provide work on the basis of those preferences though the producers may also be required to work on other sectors based on Govt. of Odisha's preference:
  - a. Welfare sector: Welfare scheme of the Government.
  - b. Social sector: Health and related issues, education, women and children issues, social issues etc.
  - c. Infrastructure sector: water resources, irrigation, agriculture, road safety, power, urban development, rural development, environment, tourism etc.
  - d. Culture, Social harmony and security related subjects.
  - e. Finance and others: tax compliance, consumer right awareness etc.

#### **ELIGIBILITY CRITERIA:**

4. Only such Indian citizen/ producers who have adequate qualifications, experience and capabilities to produce good quality audio-video production, as per the eligibility criteria prescribed for different categories will be eligible to apply only on prescribed proforma along with all requisite documents/enclosures for each category. Applications should be submitted in separate sealed envelopes for empanelment in various categories of productions.

5. I&PR Department proposes to empanel producers/production agencies in following four categories.

Category:

- Grade A Documentary films / Short films/ TV spots/Animation films / Jingles/ Advertisement films producers :-
  - The producers/ production agencies should have a minimum turn over & net worth of Rupees 50 lakh to be considered for this category.
  - b. Professional experience of having produced at least 20 documentary films/ short films/ advertisement spots/ jingles in the past years.
- Grade B Documentary films / Short films/ TV spots/Animation films / Jingles/ Advertisement films producers :
  - a. The producers/ production agencies should have a minimum turn over & net worth of Rupees 30 lakh to be considered for this category.
  - b. Professional experience of having produced at least 15 documentary films/ short films/ advertisement spots/ jingles in the past years.
- Grade C Documentary films / Short films/ TV spots/Animation films / Jingles/ Advertisement films producers :
  - a. The producers/production agencies should have a minimum turn over & net worth of Rupees 10 lakh to be considered for this category.
  - b. Professional experience of having produced at least 10 documentary films/ short films / advertisement spots/jingles in the past years.
- Grade D Documentary films / Short films/ TV spots/Animation films / Jingles/ Advertisement films producers :
  - a. The producers/ production agencies should have a minimum turn over & networth of Rupees 5 lakh to be considered for this category.
  - b. Professional experience of having produced at least 5 documentary films/ short films / advertisement spots/jingles in the past years.

#### **EXCEPTION**

# **Special Category:**

- a. Young professionally qualified producers who possess minimum 3 years degree/ diploma from any Central/ State Government Institute, recognized or affiliated from any university, in film Direction, Cinematography or Editing courses during preceding 5 years will be eligible for empanelment in the above categories. (They should have done their degree /diploma, before 31st December 2015.) They should apply with their degree/diploma certificate.
- b. They will be required to show past special experience of at least 5(five) productions.

#### Net worth:

Net worth means the excess of the book value of assets (other than fixed assets) of an enterprise over its liabilities. It would be calculated as sum of the paid up equity and free reserves minus accumulated losses, if any, in the company. The applicant shall furnish a proof of its turn over & net worth certified by a chartered accountant. (Indicating membership no. of CA with seal)

#### APPLICATION

1. All applicants shall submit the proposal in the prescribed proforma.

2. Application forms along with guidelines/rules & regulations can be downloaded from the official website of I&PR Department. (Website Link https://inpr.odisha.gov.in/)

3. Application forms should be accompanied with demand draft of 10,000/- (non refundable). Demand draft should be drawn in favour of DDO, I&PR Department issued by any of the Nationalised Bank in India.

4. Last date of submission of application form is 16<sup>th</sup> July till 5:00 P.M. at I&PR Department address through Registered post/Speed Post/ Courier.

5. The following information/documents/material must be furnished along with the application:-

 a) Ownerships of Production Studios: Legal/Valid Documentary proof of ownership of studio facilities and equipments.

b) Ownerships of Production Firm: Legal/valid Documentary proof of owner ship/ retainer ship of the firm.

c) The details of films/ programmes produced the channel /occasion on which the film was telecast / presented.

d) Turn Over from Audio Visual Productions: copy of Income Tax Re turns with PAN number, GST number & including acknowledgement issued by Income Tax Department for last three (03) years in support of income from Audio Visual Productions.

Only Audio Visual Production costs will be considered for turnover calculations.

e) Turn over & Net worth: Certificate by a Chartered Accountant (indicating membership no. of CA with seal) in support of turn over & net worth of minimum amount for applied categories.

f) Balance Sheets and profit/loss account statement: Balance sheets and profit & loss accounts of his/her firm/company for the last three financial years i.e. 2018-2019, 2019-2020 & 2020-2021 duly verified by a Chartered Accountant (indicating membership no. of CA with seal).

g) Bio-data of the key persons of his/her creative team. Composition of creative team to be submitted along with bio-data of at least Director, Cinematographer, Sound Recordist, Editor, Script Writer & Music Director. Award won by the members of the creative team as well as the producer may be stated along with the documentary proof. The producer will also submit show reel of his/her work and documentary proof of ownership of production facilities, if any.

h) The producer or his/her duly authorised representative may be required to make presentation at his/her own cost before the Selection Committee at fixed time date and venue.

i) The producer is required to quote their rates/offers, according to applied category for audio visual production in given format. (Copy of format proforma at Annexure-I). These rates will give I&PR Department a ballpark to figure their own rates. Rates quoted by producers are not binding and will only be treated as indicators for arriving at I&PR rates.

- j) The producer will have to provide as part of his/her work experience at least 20 work/ job orders and 20 work completion certificates for the work done by him/her in past years. Orders and certificates should be separate and show the kind of work done both in terms of finance and excellence according to applied category. These certificates should be self attested and issued by Govt. departments/organizations or any reputed company or any renowned production house. Censor certificate issued by Central Board of Film Certification, India will also treat as completion certificate.
- k) Undertaking on a non-judicial stamp paper- Undertaking on a non-judicial stamp paper of 100/- to the effect that the information submitted by him/ her is correct and he/she will abide by the decision of I&PR Department regarding empanelment. In case the information submitted by him/her is found to be false or fabricated in any manner, he/she may be suspended or debarred from empanelment. (Annexure-III).

#### **OTHER CONDITIONS:**

- 6. No producer will be eligible to empanelment in more than one name (either in his own name or in the name of his/her close relative). Employees and close relatives of employees of Govt. of Odisha will not be eligible for empanelment. (Close relative means spouse, dependent children/parents/brothers/sisters and other dependents).
- 7. **Director, I&PR Department,** reserve the right to accept or reject any or all applications, without assigning any reason thereof.
- 8. **Director, I&PR Department,** reserves the right to assign any Film Production work to any renowned producer, with acclaimed audio-visual productions or international/national awards, who is not on the panel.
- 9. If a producer does not respond to call for briefing/does not submit script after attending a briefing, without any valid reason, on two consecutive occasions, he/she can be removed from the list of empanelled producers.

  Director, I&PR Department may suspend producers from the panel on the basis of poor performance or any other reason.
- 10. Empanelment will be valid for two years from the date of empanelment.
- 11. The guideline/terms & conditions may be amended from time to time as considered necessary.
- 12. The empanelment does not guarantee that the work will be provided to the producers empanelled.

#### IMPORTANT NOTE

a) All criteria mentioned above are essential for applying for empanelment in above categories. Any Producer/production agency who does not meet any one of the above mentioned criteria or has not submitted the required valid and authenticated documents or applications received without requisites documentary proof would be rejected without any intimation.
