ORDER

Whereas, the petitioner i.e. Smt. Sipra Sahu was engaged as Gram Panchayat Technical Assistant (GPTA) under MGNREGA Scheme being sponsored by the EIC (Civil), Odisha under "SEBC (Women)" category.

Whereas, the petitioner was absorbed as Junior Engineer in Odisha Diploma Engineers' Service of PR & DW Department against the vacant post under "Unreserved" category and posted in Jajpur district vide PR & DW Department Office Order No. 18080, dtd. 22.09.2018 as per the database of GPTAs submitted by the PD, DRDA, Jajpur, where the category of the petitioner was mentioned as "Unreserved" instead of "SEBC".

Whereas, as per Para-5 (I) of this Department Resolution No. 5386, dtd. 19.03.2018, the GPTAs shall be brought over to the cadre of Odisha Diploma Engineers' Service of Panchayati Raj & Drinking Water Department and absorbed as Junior Engineers in phased manner subject to satisfactory completion of six years of continuous service, good service track record and **availability of vacancy in the post of Junior Engineer in the category to which they belong as per the reservation status of the vacant post.**

Whereas, after being show caused and given an opportunity of personal hearing, the petitioner was reverted from the post of Junior Engineer to GPTA vide this Department Order No. 1400, dtd. 19.01.2019.

Whereas, being aggrieved on this Department Order dtd. 19.01.2019, the petitioner filed an O.A. bearing No. 346/2019 before the Hon'ble OAT, Bhubaneswar with a prayer to quash the said impugned Order.


Whereas, in the meantime, Hon'ble High Court have disposed of the said OA vide their Order dtd. 28.10.2022 in terms of Order passed in WPC (OAC) No. 347/2019.

Whereas, Hon'ble High Court have disposed of the OA No. 347/2019 vide their Order dtd. 27.09.2022 by quashing the impugned Order i.e. Order No. 1400, dtd. 19.01.2019 of PR & DW Department i.e. order of reversion of the petitioner and upheld the order of regularization passed in favour of the petitioner i.e. PR & DW Department Office Order No. 18080, dtd. 22.09.2018.

Whereas, the matter was placed before the Scrutiny Committee under the chairmanship of Director, PR to examine the case of the petitioner for compliance of the order of the Hon'ble Court and accordingly, the Committee has furnished the recommendation.

Keeping in view the recommendation of Scrutiny Committee and orders of the Hon'ble High Court, the petitioner i.e. Smt. Sipra Sahu is hereby allowed to be absorbed as Junior Engineer against the existing vacant post in "UR" category under Odisha Diploma Engineers' Service Cadre of PR & DW Department in pursuant to this Department Office Order No. 18080, dtd. 22.09.2018 in her present place of posting and the petitioner will be adjusted against "SEBC" category, which will arise in future.


