No. SME-EL2-EL2-0108-2022- 11787 /SME, Dated 15/05/2023


In accordance with the decision of the National Council for Teacher Education in its 50th General Body Meeting and the approval of the Ministry of Education vide letter dated 7th June, 2021, the validity period of TET has been extended for life time vide letter dt. 09.06.2021 of National Council for Teacher Education.

After careful consideration, Government have been pleased to decide that the para-8 of the Guidelines for conducting Teacher Eligibility Test (TET), issued vide Resolution no. 14302/SME, dt. 04.06.2012 shall be substituted by, **"The Validity Period of OTET qualifying certificate /mark sheet shall remain valid for life time subject to fulfilment of all other eligibility conditions of appointment as may be imposed by the appointing authority from time to time."**

This will have retrospective effect from the date of enforcement of OTET Guideline i.e 04.06.2012.
