NOTICE

Applications are invited from retired "Group - D" employees for engagement against the Group – D posts in the Secretariat Establishment of the P&C Department on a contractual basis. Please submit your applications in the attached proforma along with copies of relevant documents not later than 23/6/23.

1. **Number of vacancies to be filled up: - 5 (Five)**

2. **Eligibility Conditions:**

- I. Employees who have retired from Government Service on attaining the age of superannuation and below the age of 65 years having good service records and are physically fit shall be eligible to be considered for re-employment.
- II. Employees against whom Departmental Proceedings or Criminal cases are contemplated / pending or who have been penalized for misconduct during the period of preceding five years will not be eligible for consideration.

3. **Selection Process:**

Selection will be made through a dedicated Selection Committee specifically constituted for this purpose.

4. **Tenure, Terms and Condition:**

- I. The re-engagement shall be made initially for a period of one year only.
- II. Re-engaged employees will be entitled to consolidated remuneration of Rs.10,000/- PM only.
- III. Re-engaged employees shall be governed by the provisions of Odisha Government Servants Conduct Rules, 1957 and shall be liable to be proceeded against for their misconduct, omissions and commissions as per the provisions under the Odisha Pension Rules, 1992.
- IV. The appointing authority reserves the right to terminate the re-engagement at any time due to unsatisfactory performance, by providing one month's notice. Conversely, if a re-employed employee wishes to resign, they must provide one month's written notice to the competent authority.
