No. MSME-IP-MISC-0007-2022 4245/MSME, Bhubaneswar, the 9th June, 2023

Sub: Guidelines for application of financial assistance for Human Resource Development and Promotional Activities under Odisha Food Processing Policy 2022

Till issue of detailed Operational Guidelines, Educational Institutions/Government Organizations/Industries Associations can make application to General Manager (DIC) in plain paper, giving all relevant details, to avail financial assistance as enshrined under clauses 9 and 10 of Odisha Food Processing Policy 2022. No prescribed format has so far been prescribed for making this application. General Manager (DIC) shall examine the details mentioned in the application vis-à-vis provisions under the Policy and recommend the application to Director of Industries (Odisha) within 15 working days if it is found eligible for financial assistance under the Policy. If found not eligible, he shall reject the application within 15 working days citing grounds of rejection. Director of Industries (Odisha) shall further examine the application, recommended by General Manager (DIC) and recommend the same to MSME Department within 15 working days of receipt of the recommendation from General Manager (DIC) concerned, if the application is found eligible for financial assistance under the Policy. If found not eligible, he shall reject the application within 15 working days citing grounds of rejection. MSME Department will consider the recommendation of Director of Industries (Odisha) and take appropriate decision, at the level of Secretary of the Department, either to approve or reject the proposal within 15 working days from the date of receipt of recommendation from Director of Industries (Odisha).

Rejection of application at the level of General Manager (DIC), Director of Industries (Odisha) or MSME Department must be communicated to the applicant in writing, within the dateline prescribed in the paragraph above for respective authorities, clearly mentioning the grounds/reasons for rejection.
