OFFICE ORDER

As per this Department Office Order No.4452 dtd.27.02.2019, the honorarium of Self Employed Mechanics (SEM) was last enhanced from **Rs. 1,600/- to Rs. 2,000/-** per month for each operation i.e., Operation and Maintenance of Piped Drinking Water Supply System and maintenance of Tube Wells w.e.f., 01.08.2017.

The matter relating to further enhancement of honorarium of SEMs was under active consideration of Governement for sometime. Now, after careful consideration, Govt. in PR & DW Department have been pleased to enhance the honorarium of SEMs from Rs. 2,000/- to Rs. 3,250/- per month for each operation. All other terms and conditions indicated in this Department Letter No. 11017 dtd. 12.04.2013 will remain unchanged. The expenditure shall be met out either from 15th CFC tied grant or from the 5th SFC Devolution grant available with GPs. The BDOs shall ensure the duty chart and timely payment of honorarium to the SEMs. The revised honorarium will be applicable w.e.f. 01.01.2024.
